ARTICLES OF INCORPORATION
OF
H. BRYANT SIMS, P.A.

The undersigned natural person, competent and licensed to practice Law in the State of Florida, acting hereby as Incorporator for the purpose of forming a Profession Service Corporation for profit under the provisions of Section 621, Professional Service Corporation Act, of the Florida Statutes, does hereby adopt the following articles of Incorporation:

ARTICLE I—NAME

The name of this corporation is H. BRYANT SIMS, P.A.
The principal office is 7301 South Dixie Highway, West Palm Beach, Florida 33405.

ARTICLE II—DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III—PURPOSE

The general nature and purposes of business to be transacted, promoted and carried on by the corporation are as follows:

- a. To engage in every aspect in the practice of law, and all its fields of specializations, as are engaged in by **H. BRYANT SIMS, ATTORNEY AT LAW.**
- b. To engage and render the professional services involved only through its officers, agents and employees who shall be a member in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional service as this corporation.
- c. To engage and render the professional services involved only through its officers, agents and employees who shall be a member in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional service as this corporation.
- d. To engage in no other business other than the rendition of the professional services specified herein.
- e. To do everything necessary and proper in accomplishing the purposes herein set forth and to do anything incidental thereto which is not forbidden under the laws of the State of Florida.

ARTICLE IV—CAPITAL STOCK

a. This corporation is authorized to issue 100 shares of One Dollar (\$1.00) par value common stock which shall be designated as "Common Shares."

b. The consideration to be paid for each share shall be payable in lawful money or property, labor or services.

c. Shares of the corporation's stock and certificates shall be issued only to members in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional services as this corporation.

ARTICLE V—PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation, shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI—INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 7301 South Dixie Highway, West Palm Beach, Florida 33405, and the name of the initial registered agent of this corporation at that address is H. BRYANT SIMS, ATTORNEY AT LAW.

ARTICLE VII—INITIAL BOARD OF DIRECTORS

This corporation shall have one (1) director(s) constituting the initial Board of Directors. The number of directors may be either increased or decreased from time to time by the bylaws, however, there shall never be less than one Director nor more than five. 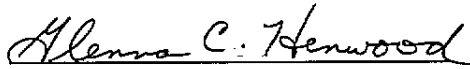

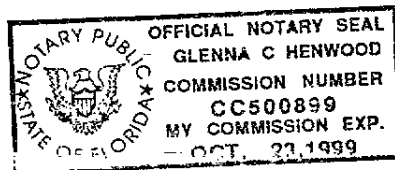
