**Article I - Name**

The name of the corporation is: Solid Image of Central Florida, Inc.

**Article II - Duration**

This corporation shall exist perpetually.

**Article III - Purpose**


#### **Article IX - Initial Officers**

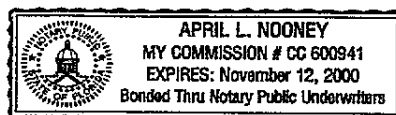
