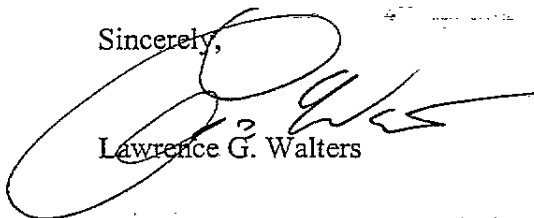

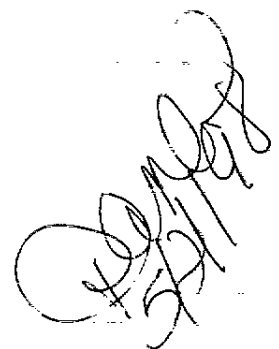

ARTICLE I. NAME

The name of this corporation shall be 1295 S.O.B.T., Inc.

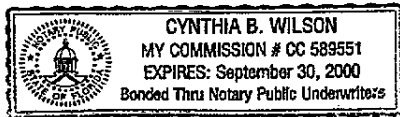
