ARTICLE I. CORPORATE NAME.

The name of this corporation is Custom Concrete Construction, Inc.

ARTICLE II. PRINCIPAL OFFICE.

The principal place of business and mailing address of this corporation are 16880 Gator Road, Suite 271, Fort Myers, FL 33912.

ARTICLE III. CAPITAL STOCK.

The number of shares of stock that this corporation is authorized to have outstanding at any one time is 100, all of one class, with a par value of \$ 1.00 per share.

ARTICLE IV. INITIAL REGISTERED AGENT AND OFFICE.

ARTICLE V. INCORPORATORS.

The corporation shall have a Board of Directors and there shall be three directors elected by the shareholders. The number of directors may be increased or decreased by a vote of the shareholders. The period of duration of the corporation shall be perpetual.


ARTICLE VIII. PURPOSE.

The undersigned has executed these articles of incorporation on May 15, 1998.







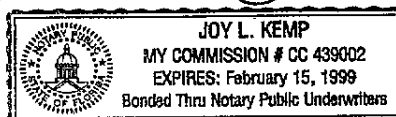
