Please excuse this delay in the submission of my FEI Number due to a miscommunication with the Internal Revenue Service. I promptly applied for the FEI Number after I received a letter of notification from the Florida Department Of State, saying that I needed to obtain an FEI Number. I later received a letter from the Internal Revenue Service after a while saying that they needed to know the principal activity of my business which I informed them of right away. I called the Internal Revenue Service yesterday because I had not heard from them. I regret now that I had not done so earlier but I simply did not know any better and I thought that these sorts of things normally take a long time. The person with whom I spoke, told me that my application was not in the system and that this was because when I sent the letter to them, about the principal activity of my business, I had not included a COPY of my application and they also needed information on the date that the business had started. This was not specified on the letter I received from them. I very much regret that this has happened, but it was due to a lack of information from the IRS. I sincerely hope that I will not be charged a penalty for being late providing the FEI Number.

Enclosed please find the copy of my first application form, the second one with the FEI Number and a copy of the returned check for the \$150 filing fee which I paid in April.
