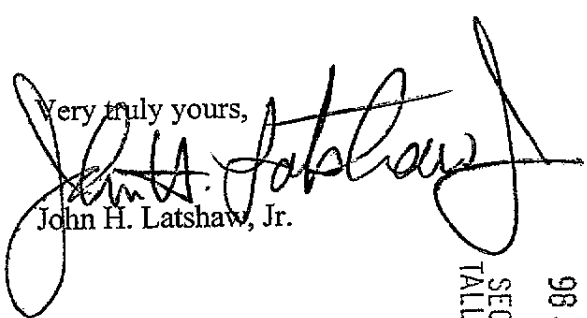

ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
OF  
LA-BOND, INC.

Pursuant to the provisions of Section 607.1006, Florida Statutes, this corporation adopts the following Articles of Amendment to its Articles of Incorporation:

The following amendments are adopted as follows:

FIRST: Article I is amended to reflect a change in corporate name to La-Bond, Inc.

SECOND: Article III is amended to reflect that the corporation has changed its corporate stock from Ten Thousand (10,000) shares of common stock, par value of one dollar (\$1.00), per share, to One Hundred Thousand (100,000) shares, par value of One Dollar (\$1.00) per share.

THIRD: The date of the Amendment's adoption is July 2, 1998.

FOURTH: The amendment does not provide for an exchange, reclassification or cancellation of issued shares, and shareholder approval is not required.

FIFTH: The amendment was, however, approved by the sole stockholder, whose vote is sufficient for approval.
