ARTICLE I - NAME and LOCATION

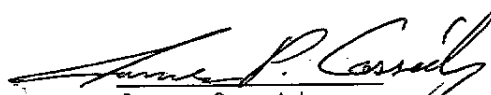
ARTICLE IX-- INDEMNIFICATION

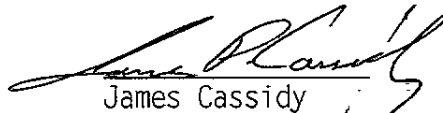
