The undersigned, for the purpose of forming a corporation under Chapter 621 F.S., the Professional Association Act, hereby adopt the following articles of incorporation:

ARTICLE I

NAME



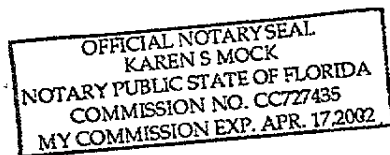


