**ARTICLES OF INCORPORATION
OF

The undersigned acting as incorporator of this corporation pursuant to Chapter 607 of the Florida statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such corporation.

ARTICLE I- NAME AND ADDRESS OF CORPORATION

The name of the corporation shall be Swanson Production Partners, Inc.. The address of the corporation shall be 938 Saint Croix Ct., Orlando, FL 32835.

ARTICLE II-TERM OF EXISTENCE

This corporation shall exist perpetually.

ARTICLE III-NATURE OF BUSINESS

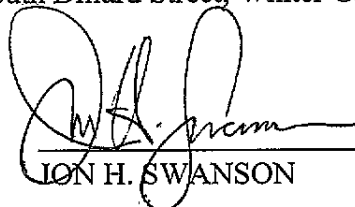
ARTICLE VIII-AMENDMENT TO ARTICLES
