## ARTICLE I - NAME AND ADDRESS

The name of this corporation is **MEDISTAT PHARMACY SERVICES, INC.** (the "Corporation"). The address of the principal office and the mailing address of the Corporation is 187 Cameron Court, Weston, Florida 33326.

#### <u>ARTICLE II - PURPOSE</u>
