THE NAME OF THE CORPORATION IS **CITY & COUNTRY LAWN SERVICE, INC.**

ARTICLE TWO

THE PERIOD, TERM AND DURATION IS **PERPETUAL**.

ARTICLE THREE

THIS BUSINESS, IF GRANTED CORPORATE STATUS WILL COMMENCE ITS BUSINESS AS A FULL SCALE LAWN SERVICE, WHEREIN, WE WILL PROVIDE LAWN SERVICE OF ALL KINDS. THE BUSINESS WILL TRANSACT ALL OF ITS' BUSINESS UNDER THE NAME OF **CITY & COUNTRY LAWN SERVICE, INC.** ALSO, IF GRANTED CORPORATE STATUS THE BUSINESS WILL CONDUCT ANY OTHER SIMILAR BUSINESS OR BUSINESSES AS THE BUSINESS MAY SEE FIT FROM TIME TO TIME AS PROVIDED FOR BY STATUTE.


