The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation is **BIG OAKS RECREATION & EDUCATION, INC.**

The principal place of business of this corporation shall be 615 Grand Chenier Cove, Chuluota, Florida 32766.

The Bylaws of the corporation may be amended by majority vote of either the directors or the shareholders.

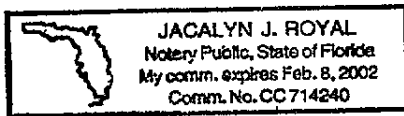
