Article I. Name

The name of this corporation is: Truxell Homeowner's Association, Inc.

Article II. Initial Principal and Registered Office and Agent

The initial principal office and the street address of the initial registered office is 135 Rio Vista Drive, Sopchoppy, Florida 32358. The mailing address of the corporation is Rural Route 1, Box 434, Sopchoppy, Florida 32358. The initial registered agent is Clyde W. Truxell, III.

Article III. Capital Stock

This corporation is authorized to issue 10,000 shares of \$1.00 per share par value common stock.

Article IV. Preemptive Rights

Upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he or she already holds, every shareholder shall have the right to purchase his or her pro rata share (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.


Article V. Management of Corporation by Shareholders


