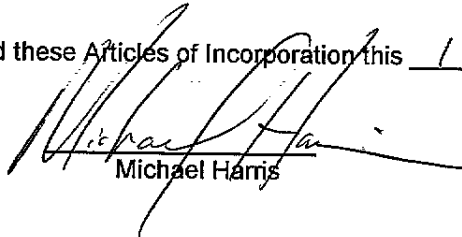
ARTICLE VII – INDEMNIFICATION
