Article II - Purpose

The general purpose for which the Corporation is organized is to include the transaction of any and all lawful business for which Corporations may be incorporated under the Florida General Corporation Act, the laws of the State of Florida or of the United States of America. The corporation is formed specifically for the protection and limited liability granted under said act, as well any and all other protection granted by statutes, rule, and case law.

Article III - Duration
