### ARTICLE I

### <u>Name</u>

The name of this corporation shall be:

# ARTICLE II

# Principal Place of Business

The principal place of business is to be located at 1803
Buttonwood Drive, Oldsmar, Florida 34677.

### ARTICLE III

### Term of Existence

The duration of this corporation is to be perpetual.

#### ARTICLE IV

### <u>Purpose</u>

To own, operate and maintain a video production and distribution company and generally to do and perform everything necessary for carrying out the aforesaid purposes, and to engage in

such other business or businesses, whether related thereto or not, as may be approved by the Board of Directors and which businesses are permitted by the laws of the State of Florida.
