ARTICLES OF INCORPORATION

OF

TAG CONCEPTS, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I—NAME

The name of the corporation shall be:

TAG CONCEPTS, INC.



ARTICLE II—PRINCIPAL OFFICE

ARTICLE III—NATURE OF BUSINESS

The corporation is a corporation for profit and is organized for the following general purposes: selling clothing; to carry on any lawful businesses or activities relating thereto; and to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act.

ARTICLE IV—TERM OF EXISTENCE

The corporation shall have perpetual duration.
