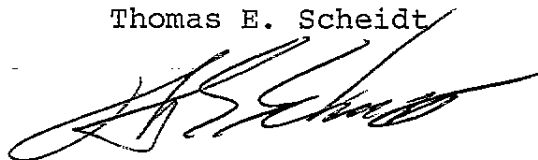

ARTICLES OF INCORPORATION
OF

Article I - Name

The name of this corporation is Bee Hive Boring, Inc.

Article II - Business and Activities

This corporation may, and is organized and authorized to, engage in any activity or business permitted under the laws of the United States and the State of Florida.

Article III - Capital Stock

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1,000 shares of common stock having a par value of \$1.00 per share, with the consideration to be paid for each share to be in money, property or services, as may be fixed by the Board of Directors.

Article IV - Term of Existence

This corporation shall have a perpetual existence.

Article V - Initial Registered Office and Agent

The street address of the initial principal and registered office of this corporation is 4101 Canoe Creek Road, St. Cloud, Florida 34772. The name of the initial registered agent of this corporation at that address is Thomas E. Scheidt.

Article VI - Initial Board of Directors
