ARTICLE I
NAME OF THE CORPORATION

The name of the Corporation is YOUNG'S OF CENTRAL FLORIDA, INC.

ARTICLE II

The principal office of the Corporation is located at 2155 W. Colonial Dr., Orlando, FL 32804.

ARTICLE III

The general nature of the business to be transacted by the Corporation is to engage in any and all business permitted under the laws of the State of Florida.

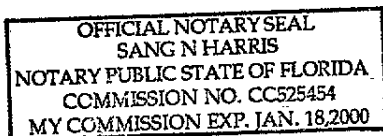
