

ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION OF

Name


The name of the corporation is Low Cost Software, Inc. (the "Corporation").

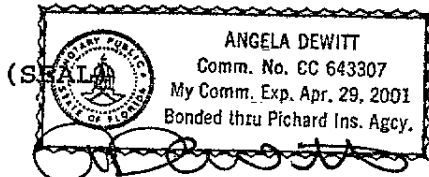
