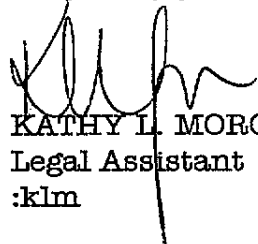

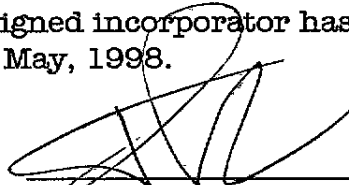
**ARTICLE VIII
