**ARTICLES OF INCORPORATION**

**OF**

**THE UNDERSIGNED**, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I**

**NAME**

The name of this corporation is La Voz Latina, Inc. The principal place of business is 125 W. Romana Street, Suite 224, Pensacola, Florida 32501.

**ARTICLE II**

**DURATION**

The duration of this corporation is perpetual.

**ARTICLE III**

**PURPOSE**

**INCORPORATORS**



These Articles of Incorporation may be amended in the manner provided by law.






