This letter is written as a formal request for the reinstatement and abatement of penalties for the above referenced. Due to reasonable cause.


The Taxpayer mailed to your office the 1999 Annual Report of renewal and a check in the amount of \$150.00 on March 30, 1999. See copy of the check enclosed. The check was not returned and was cashed by the State. The Taxpayer thought all was O.K. It was not until the Taxpayer received the reinstatement application, and then he recognized that there was a problem.
