**FIRST:** The name of the corporation is TBTG, Inc. a corporation.

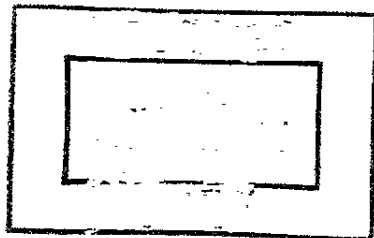
**SECOND:** The dissolution was authorized on <sup>July</sup>~~June 12~~, 2000.


**RESOLVED**, it would be in the best interests of the Corporation and its shareholders for the Corporation to be dissolved.
