ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is Wm. Court, Inc.

ARTICLE II - PRINCIPAL OFFICE

The mailing address of this corporation shall be: 101 N.W. 18th Street

ARTICLE III - PURPOSE
