The undersigned incorporator hereby forms a professional association under Chapter 621 of the laws of the State of Florida.

ARTICLE I

NAME

The name of the professional association shall be: **SMITH & ASHBURN, P.A.** The address and principal office of this corporation shall be 1330 Thomasville Road, Tallahassee, Florida 32303, and the mailing address of the professional association shall be the same.

ARTICLE II

NATURE OF BUSINESS

This professional association may engage in every aspect of the business of rendering the same professional services to the public that an attorney at law, duly licensed under the laws of the State of Florida, is authorized to render. The professional association elects to have preemptive rights.




