ARTICLES OF INCORPORATION

OF

AMS V, INC.

ARTICLE I- NAME AND ADDRESS

The Name of this corporation is AMS V, INC. (hereafter referred to as the corporation.) The Corporation's principal address is 941 S.W. 8th Street, Pompano Beach, Florida 33069.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on May 20, 1998, the date these Articles of Incorporation are filed with the Florida Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - POWERS

This Corporation shall have all the powers conferred upon corporations organized under the laws of the Florida Statutes.

ARTICLE V -CAPITAL STOCK

This Corporation is authorized to issue 250 shares of one and no/100 dollars (\$1.00) per value common stock.

ARTICLE VI - PRE-EMPTIVE RIGHTS

Every shareholder, upon the issuance of any new stock of this Corporation of the same kind, class or series of that which he already holds, shall have the right to purchase his pro-rata share at the price at which it is offered to others.

ARTICLE VII - INITIAL REGISTERED AGENT AND OFFICE

The street address of the initial registered office and agent of this Corporation is 941 S.W. 8th Street, Pompano Beach, Florida 33069, and the name of the initial registered agent of this Corporation, at that address, is John E. Murray.

ARTICLE VIII - INITIAL BOARD OF DIRECTORS

This Corporation shall have one director initially. The number of directors may be either increased or diminished from time-to-time by the bylaws, but shall never be less than one (1). The name and address of the initial director of this Corporation is:

The Corporation shall indemnify an officer or director, or any former officer or director, to the full extent permitted by law.

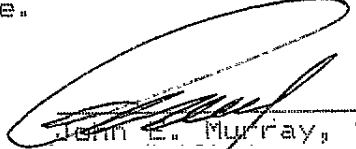
ARTICLE XII - REGISTERED AGENT

Pursuant to Chapter 48.091, Florida Statutes, the following is submitted in compliance with this act:

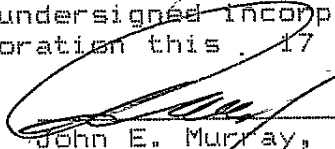

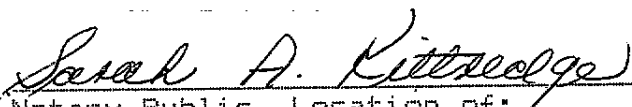
