We are the new accountants for Season's Flowers on the Beach, Inc. and as per our telephone conversation today with the Dept of State officer we were advised to send this letter of explanation in order to abate the penalties of re-instatement as follows:

We are in receipt of your correspondence sent on July 3, 2001(copy attached) please be advised that Mrs. Suolet hired an accountant to handle her books for the calendar year 2000 and the year in progress of 2001. He had possession of all her past and current records (Nrs. Soulet will pack and mail to him all pertinent accounting forms and records). However, she was not being provided the service that she expected. She requested all her bank statements and correspondence to be send back to her. It took more than a month to get them. When she received everything back the Annual Report for 2001 was among those documents. She was not advised by the professional accountant, who was supposed to look after her company, to file before May 1st. Her previous accountant had always advised her every year. She has never been late. By relying on this professional many problems have occurred to Mrs. Suolet, not only with the Department of State but with the Internal Revenue Service. As of now, we are working on these matters to clear all the wrong doings caused by relying on him. We believe that Season's Flowers on the Beach,Inc.Mrs. Suolet's company not be penalized.
