You should have recently received a post card Annual Report Notice from the Florida Department of State announcing a new procedure for filing your 2004 Annual Uniform Business Report. Although you can still request or download a preprinted Annual Report, you now have an option of filing online.

To file online, you go to <u>www.sunbiz.org</u>, and there is a box that says "Click here to file your 2004 Annual Report!" The next screen will ask for the document number of the entity_(which_appears_on_the_post_card_Notice, if needed). After submitting the document number, the next screens will be a series of fields to confirm/update information.

If I am the Registered Agent for your company, I am requesting and authorizing you to change my address information to W. Charles Shuffield, ShuffieldLowman, Gateway Center, 1000 Legion Place, Suite 1700, Orlando, Florida 32801. You can change this information both on the preprinted forms and online. My signature is <u>not</u> required to change my address. However, if I am not already identified as the Registered Agent, and you would like me to serve in this capacity, my signature is required. If you are filing online, you have my authorization to electronically type in my acceptance signature.

Finally, we advise you to make a copy of the completed form and check for your records before you mail the original to the Florida Department of State. If you file online, you can download a copy of the electronic annual report approximately 48 hours after it has been submitted.

Failure to file the UBR by May 1st can result in substantial penalties, and failure to file the UBR at all will result in the administrative dissolution of your company.
