ARTICLES OF INCORPORATION OF

IJO TRUCKING COMPANY, INC.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is IJO TRUCKING COMPANY, INC.

ARTICLE II

The period of duration of the corporation is perpetual.

ARTICLE III

This corporation is organized for the purpose of operating a trucking business and any other activity or business permitted under the laws of the United States and the State of Florida.
