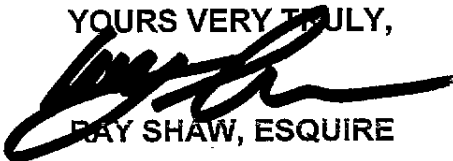

The undersigned, acting as Incorporator of a corporation under the FLORIDA GENERAL CORPORATION ACT, adopt the following ARTICLES OF INCORPORATION for such corporation:

1. The name of this corporation is **SUMMIT LEASING, INC..**
2. The period of its duration is perpetual.
3. The purpose is to engage in any activities or business permitted under the laws of the United States and Florida.
4. The corporation is authorized to issue one thousand(1,000) shares of stock, all of one class, at \$1.00 par value.
