**ARTICLES OF INCORPORATION**

In compliance with the requirements of Chapter 607 of the Florida Statutes, the undersigned, being natural persons, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

**ARTICLE I. CORPORATE NAME.**

There are two(2) initial shareholders: Gary Gunter and Misty Gunter.


#### **ARTICLE VIII. PURPOSE**




