ARTICLES OF INCORPORATION
OF
MASTER CLEANING OF MIAMI, INC

The undersigned subscribes to these Articles of Incorporation, natural person, competent to contract, does hereby form a corporation for profit under the laws of the United States and the State of Florida. Corporate existence shall begin upon acceptance of these Articles of Incorporation, as defined in section 1244, subdivision (c)(2) of the Internal Revenue Code.

ARTICLE I
NAME

The name of this corporation is

ARTICLE II
PURPOSE

This corporation is organized for the following purposes:

1).-To engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE III
CAPITAL STOCK

This corporation is authorized to issue 1000 shares of common stock. The common stock of this corporation shall have the following characteristics:

a) Par value shall be \$1.00 per share.
