Attached please find a completed annual business report and checks in the amount of \$450 made payable to the Department of State. Please reinstate this corporation for the years 1999 through 2001. We request that you waive any penalties for filing each of the last three years for the reasons explained below.

This annual report was originally mailed in November 1999 but returned for inappropriate payment. The officers did not receive a form to file during the spring of 1999 and penalties had been waived for that year. An attempt was made in November 1999 to file the form and change the address. The officer received a letter dated December 28, 1999 informing her that her payment of \$150 was not accepted and must include another \$150 if not returned by January 1, 2000. Payment was then made by bank check in the amount of \$300 during April 2000. This check has never been cashed and is now void. Per a discussion with your department on September 6, 2001, an annual report has never been accepted for this company.
