

# ARTICLES OF INCORPORATION OF CENTRAL FLORIDA BUILDING SPECIALTIES, INC.

THE UNDERSIGNED, acting as sole incorporator of CENTRAL FLORIDA BUILDING SPECIALTIES, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

#### ARTICLE I

#### Name

The name of the corporation shall be **CENTRAL FLORIDA BUILDING SPECIALTIES, INC.** 

#### ARTICLE II

#### **Shares**

The number of shares which the corporation shall have authority to issue is Ten Thousand (10,000), consisting of a single class of common stock, One Cent (\$0.01) par value per share.

#### ARTICLE III

#### **Principal Office**

#### **Initial Board of Directors**

The number of Directors constituting the initial Board of Directors of the corporation is one. The number of Directors may be increased or decreased from time to time, but in no event shall the number of Directors be less than one (1). The person who is to serve as initial Director until the first annual meeting of the shareholders of the corporation or until such successor Directors are elected and shall qualify is Jose Soler.
