THE UNDERSIGNED, acting as sole incorporator of LYNCH FAMILY ENTERTAINMENT, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name

The name of the corporation shall be LYNCH FAMILY ENTERTAINMENT, INC.

Initial Board of Directors



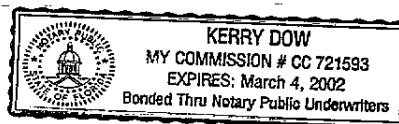
