

ARTICLES OF INCORPORATION

OF

CUSTOM PRODUCTS CORP.



ARTICLE 1. - NAME

The name of the corporation is CUSTOM PRODUCTS CORP.

ARTICLE 2. - PRINCIPAL OFFICE

The principal office of the corporation shall initially be at 514 Colonia Lane, Nokomis, FL 34275. The corporation may change its principal office from time to time as permitted by law.

ARTICLE 3. - MAILING ADDRESS

The initial mailing address of the corporation shall be 514 Colonia Lane, Nokomis, FL 34275. The corporation may change its mailing address from time to time as permitted by law.

ARTICLE 4. - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE 5. - SHARES

This corporation is authorized to issue 1,000 shares of voting common stock with a par value of \$1.00 per share.

ARTICLE 6. - INITIAL REGISTERED OFFICE AND AGENT

directors or arising out of their status as such.

ARTICLE 11. - AMENDMENT

This corporation reserves the right to amend or repeal any provisions contained in the Articles of Incorporation, or any amendment to them, and any right conferred upon the shareholders is subject to this reservation.
