## ARTICLES OF INCORPORATION

### ARTICLE I - NAME

The name of this corporation is A & A Group, Inc.

### ARTICLE II - PRINCIPAL OFFICE

### ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.
