**ARTICLES OF DISSOLUTION
OF

Pursuant to the provisions of Sections 607.1402 and 607.1403 of the *Florida Statutes*, the undersigned Florida professional service corporation hereby adopts the following Articles of Dissolution:

ARTICLE I – NAME OF CORPORATION
