ARTICLES OF INCORPORATION

The undersigned subscribers to these articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a EFFECTIVE DATE corporation under the laws of the State of Florida.

ARTICLE 1

The principal place of business and mailing address of this corporation shall be:

The general nature of the business to be transacted by this corporation is:

- 1. To engage in any activity or business permitted under the laws of the United States and of this State.
- 2. To the same extent as natural persons might or could do, to purchase or otherwise acquire, and to hold, own, maintain, work, develop, sell, lease, consult, exchange, hire, convey, mortgage or otherwise to dispose of and deal in, lands and leaseholds, and any interest, estate, and rights in real property, and personal or mixed property, and any franchises, rights, licenses or privileges necessary, convenient or appropriate for any of the purposes herein expressed.

- 3.
