## ARTICLES OF INCORPORATION

OF

# RICHARD & BRENDA PANCAKE, INC.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:

## **ARTICLE ONE: NAME**

The name of this corporation shall be: RICHARD & BRENDA PANCAKE, INC.

## **ARTICLE TWO: NATURE OF BUSINESS**

The general purpose for which this corporation is initially organized is to operate a residential building construction business; and for the further purpose of engaging in any activities or business permitted under the laws of the United Sates and Florida.

## **ARTICLE THREE: DURATION**

This corporation shall have perpetual existence.

#### **ARTICLE FOUR: CAPITAL STOCK**

This corporation is authorized to issue One Thousand (1,000) shares of One Dollar (\$1.00) par value common stock. By general consent of the Stockholders, it is their desire to designate the initial capital stock of this corporation as Section 1244 Stock, as defined under the Internal Revenue Code. As such stock will qualify for all rights and privileges of Section 1244 Stock.

# **ARTICLE FIVE: ADDRESS**

The street address of the corporation's initial registered office is 1225 Ingleside Place, Cedar Key, FL 32625 and the name of the initial Registered Agent is BRENDA J. PANCAKE, whose address is 1225 Ingleside Place, Cedar Key, FL 32625. The stockholders may from time to time designate such other address and place as the registered agent, subject to requirements of Florida law.

#### ARTICLE SIX: MANAGEMENT

All corporate powers shall be exercised by or under the authority of, and the business and affairs of this corporation shall be managed under the direction of, the shareholders of this corporation. Each stockholder shall be entitled to one vote in person or by proxy for each share of voting stock held by him or her. A majority of the outstanding shares of the corporation entitled to vote, represented in person or by proxy, shall constitute a quorum at any meeting of the stockholders for the management of the business of the corporation.
