



ARTICLES OF AMENDMENT

Article I. Name

The name of this Florida Corporation is: Cherry Hill Development Corporation

Article II. Amendment

The Articles of Incorporation of the Corporation are amended as follows:

ARTICLE I. NAME CHANGE

The name of the corporation shall change from Cherry Hill Development Corporation to eCommerce Tools Inc., with an address of 277 Royal Poinciana Way, Suite 192, Palm Beach Florida, effective December 7, 1998.

ARTICLE XII SPECIAL AUTHORITY OF BOARD OF DIRECTORS AND WAIVER OF DISSENTERS RIGHTS

The Board of Directors shall be and are hereby authorized to enter into on behalf of the corporation and to bind the corporation without shareholder approval, any and all acts approving (a) the terms and conditions of a merger and/or a share exchange; and (b) divisions, combinations and/or splits of shares of any class or series of stock of the corporation, whether issued or unissued, with or without any change in the number of authorized shares; and shareholders affected thereby, shall not be entitled to dissenters rights with respect thereto under any applicable statutory dissenters rights provisions.

Article III. Date Amendment Adopted

The amendment set forth in these Articles of Amendment was adopted on December 7, 1998.

Article IV, Shareholder Approval of Amendment

The amendment set forth in these Articles of Amendment was proposed by the Corporation's Board of Directors and approved by the shareholders by a vote sufficient for approval of the amendment.
