The undersigned incorporator, for the purpose of forming a corporation under the provisions of Chapter 607 of the Florida Statutes, hereby adopts the following articles of incorporation.

**ARTICLE I - NAME**

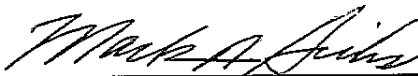
## **ARTICLE VII - INCORPORATOR**
