I, the undersigned for the purpose of forming a corporation for profit pursuant to the laws of the State of Florida, do hereby adopt the following Articles of Incorporation:

Article I
CORPORATE NAME

The name of this corporation shall be **STEPHANIE'S DESIGN & REPAIR, INC.** The principal office and mailing address of this corporation shall be 1712 North 16th Court, Suite B, Hollywood, FL 33020. A second location will be opened in St. Thomas in the U.S. Virgin Islands during the latter part of 1998.

Article II
NATURE OF BUSINESS

This corporation may engage in any activity of business permitted under the laws of the United States and its territories, of the State of Florida or of any other place in the world. The corporation will initially have two locations. Other locations may be added from time to time.

Article III
CAPITAL STOCK

This corporation is authorized to issue 500 shares of \$1.00 par value common stock. Authorized capital stock may be paid for in cash, services or property, at a just value to be fixed by the Board of Directors of this corporation at any regular or special meeting.




