1. The name of the corporation is EDUCATIONAL ENDEAVORS SECRETARY OF STATE

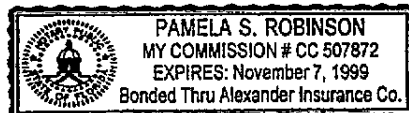


