I am sending this letter to explain that a second notice to file the Uniform Business Report was never received for Educational Endeavors Incorporated P98000048280 or Global Discoveries Incorporated P98000047355. Therefore I was under the impression that both reports had been received and processed. As I stated in my letter dated September 27<sup>th</sup>, both Uniform Annual Reports for Educational Endeavors Incorporated and Global Discoveries Incorporated were sent on April 8, 2002 in the same envelope. I do not know why the state does not show record for the Educational Endeavors Incorporated Uniform Business Report and have no explanation for this except that some sort of processing error occurred.

I was not aware the report had not been received until licenses were being renewed and the state website did not show the report having been filed. Once I found out, I called the state to research what had occurred. If I had received a second notice, I would have contacted the division of corporations immediately to correct this matter. I would not have allowed this situation to get out of control to the point of the corporation being dissolved. This is a very serious matter and the repercussions are extremely damaging.

As requested I am enclosing a copy of the Uniform Business Report that was sent on April 8, 2002, and resigning it in blue pen. I am also including a check for the amount of \$ 150.00 for the report.

I thank you in advance for your assistance in this matter. In the future, I will be sure to send each corporation in separate envelopes and will check on the web-site in order to make sure everything was processed correctly.
