We, the undersigned subscribers to these Articles of Incorporation, hereby form a corporation under the laws of the State of Florida.

**ARTICLE I**

The name of the corporation is: Ambulatory Strategies, Inc.

**ARTICLE II**

The general purposes for which the corporation is organized are:

1. To engage in all phases of the consulting and management business.
2. To transact any business for which corporations may be incorporated under the Florida General Corporation Act.
3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

**ARTICLE III**

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is One Thousand shares of common stock of a single class with a par value of One Dollar (\$1.00) per share.

**ARTICLE IV**

The capital with which this corporation will begin business shall not be less than Five Hundred Dollars (\$500.00).

**ARTICLE V**

This corporation shall exist perpetually.

**ARTICLE VI**

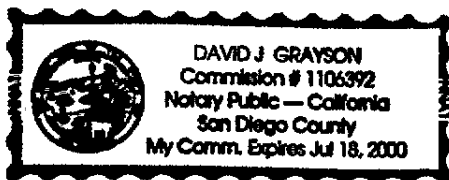

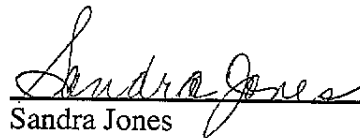
