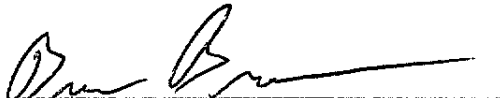

1. NAME: The name of the corporation is :**KCS PLASTICS, INC.**
2. PLACE OF BUSINESS: The principal place of business and mailing address of the corporation is: **6201 Southwest 183rd Way, Ft. Lauderdale, Fl. 33331**
3. TERM: The duration of the corporation shall be perpetual.
4. PURPOSE: The purpose of this corporation is to transact any or all lawful business for which corporations may be incorporated under Chapter 607 Florida Statutes.
5. CAPITAL STOCK: The corporation shall have the authority to issue 20(Twenty) shares of common stock, in one class only, each with a par value of \$0.01. The board of directors may dispose of the authorized but unissued stock from time to time, but every stockholder may purchase his pro-rata share, as near as can be done without the issuance of fractional shares, on the sale for cash of any previously unissued or new stock of this corporation at the same price at which it is offered to others.

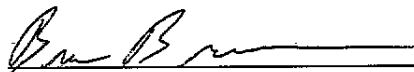

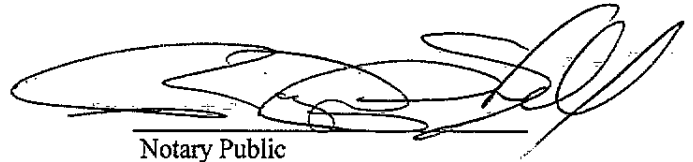

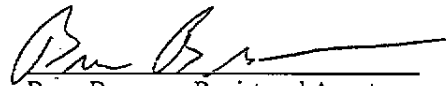
