Article I - Name and Mailing Address

The name of the corporation is Denise C. Swearingen, P.A. and the mailing address is P.O. Box 76328, St. Petersburg, FL 33734.

Article II - Duration

The term of existence of the corporation is perpetual, commencing on June 1, 1998.


