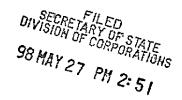

ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is MEDIAMATTERS, INC.

ARTICLE II CORPORATE EXISTENCE
